

Gutta-percha points for canals

INSTRUCTIONS FOR USE

Gutta-percha is one of the dental restorative materials. Dentists use it as a root canal filler when treating endodontic diseases. Our gutta-percha got the ShangHai New Excellence Product award.

- 1. It is white (or pink) spicule, odorless, without irritation with disinfection.
- 2. It is impervious to X-rays, we clearly see the filling of the canal.
- 3. It has a certain firmness. It can easily get into the fine and clogged duct.
- 4. Its diameter and size are in accordance with the duct reamer.

COMPOSITION

High quality natural gutta-percha, zinc oxide.

1) INDICATIONS OF USE

It is used to fill the canal when dentists perform endodontics.

2) CONTRAINDICATIONS

None known.

3) WARNINGS

- It must be disinfected with alcohol before use.
- Should not be applied to allergic patients.

4) SPECIFICATIONS

• It is produced in accordance with ISO 6877. It can be customized in size according to the requirements of the ducts with varieties of types.

5) STORAGE AND EXPIRY
